RULES AND REGULATIONS FOR PARTICIPATION IN THE PRIZE DRAW

Article 1. ORGANISATION

Article 2. PARTICIPATION

Participation in the Lottery is open to all Healthcare professionals who are attending the ESC Congress 2024 onsite only

Participants confirm that any data provided as part of his/her participation is accurate. Article 4. THE PRIZES

The responsibility of the Organising Company is limited to the maximum overall amount of the prizes involved.
